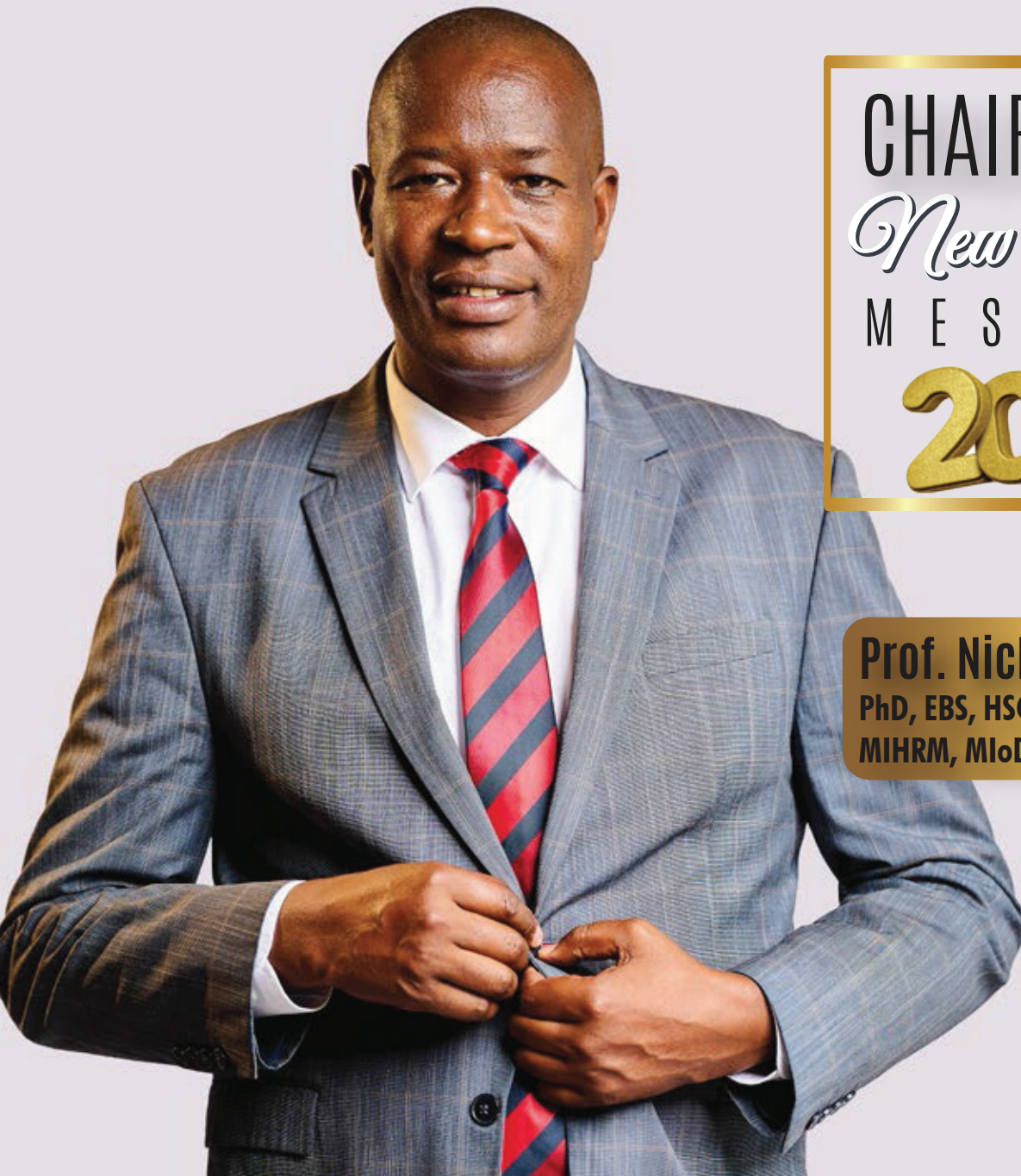

## ***The Kenya Revenue Authority (KRA)***

***Commissioner*** for Legal Services and Board Coordination, CS Paul Matuku, EBS has called on all professionals to play a leading role in the fight against corruption noting that most corruption scandals in the country involve professionals. He made this clarion call on 1st Dec 2023 during a courtesy call by the Executive Committee of the Association of Professional Societies in East Africa (APSEA) led by its 1st National Vice Chairman Mr. Leonard Ashindu who visited KRA's Ushuru Towers, Upper Hill offices that houses the Legal department.



He noted that professionals stand in a position of trust and confidence and is relied upon by the public to play a vital role in tackling corrupt conduct.

“Over the years, we have observed that majority of the corruption investigations undertaken by EACC involve professionals in various fields,” the KRA Commissioner said. During the meeting. APSEA committed to rally its professional bodies to make a Tax Compliance Certificate as one of the mandatory requirements for renewal of membership. KRA and APSEA are discussing a formal Collaborative Framework on tax education awareness and initiatives to promote ethics & integrity.







## The Kenya Association of Radiologists

---

**Kenya Association of Radiologists (KAR)** is the umbrella body to which all Radiologists in Kenya belong. It has a rich history spanning decades and was incorporated in 1973. KAR has grown steadily in membership over the years from a handful of foreign-trained pioneers to the now more than 250 radiologists who are predominantly trained locally at the University of Nairobi, Moi University and the Aga Khan University.

Starting off initially as a social organization because of the times then, KAR has now assumed many roles including monitoring the development of radiology in Kenya, promoting standards of radiology practice, ensuring patient safety, quality clinical imaging reporting, advisory role to government, effective communication with other medical professionals and protecting the interests of radiologists.

In line with the devolution of healthcare services in Kenya, the Kenyan radiologists cover all the counties in Kenya. The availability of teleradiology practice has made work easier for radiologists to reach far flung areas such as West Pokot and Mandera.



Through the National Health Insurance Fund, soon to be Social Health Insurance Fund, the radiologists contribute to Universal Health Coverage.


**Vision:** to be the guide and leader in the practice of radiology, influencing medical policy, training, research and innovation.

**Mission:** to promote best practices and safety, education, research, innovation and policy in medical imaging aimed at addressing the imaging-related healthcare needs of the Kenyan public.

**Radiology** is the use of imaging devices in the human body for diagnostic and sometimes intervention and therapeutic purposes. Radiologists are the specialists trained to perform this.

Like other medical specialists, the radiologists, as medical officers enroll in a four-year postgraduate programme in radiology which covers both diagnostic Imaging and interventional radiology. Some of the specialized radiologists can then proceed for training in various fields of super specialization in and outside the country. We currently have interventional radiology sub specialization at the University of Nairobi.

**Local faculty in collaboration with international partners are currently developing fellowship programmes in more subspecialist fields so that more radiologists can acquire these skills locally.**

**It is difficult to conceive any health delivery system without radiology. Indeed, radiology has become the cornerstone of quality medical practice everywhere in the world on account of the medical services it provides. It links all the other specialties on a common platform of imaging.**

**The 'mechanization' of medicine with high-end imaging gadgets means that radiologists are in the cutting edge of technological development in medicine.**

Radiology has expanded all the way from x-ray reporting and ultrasound examinations through to producing CT / MR/ PET scans, and being part of interventional medicine where imaging is used in therapeutic procedures. The evolution of technology has also enabled entry of the now common place artificial intelligence in medicine with one of the first ports of call being radiology.

Clearly this is a new innovation with a lot of potential in radiology and medicine in general. Radiologists are currently evaluating its use to find areas where it can be an advantage and how to introduce it without it being a threat to patient safety and quality healthcare provision.



A key area where KAR is currently working on is how to regulate the widening imaging platform that now includes radiographers, sonographers, gynecologists, emergency physicians, critical care specialists, and even non-medical businessmen whose prime agenda is to make money at the expense of patient safety and other health regulations. Radiologists are the decisive players and their role in regulating this field is paramount.

With more consultation between the various stakeholders, it is possible to streamline this key sector in our health delivery system.

With this in mind the future of radiology is robust and radiologists through the use of emerging technologies and increased availability in multi-disciplinary healthcare teams greatly add value to health care delivery in Kenya and beyond.
